I obtained my master's degree in Civil Law from Southwest University of Political Science and Law in 1986 and remained in Southwest University of Political Science and Law. Currently, I am a doctoral supervisor, second-level professor, editor-in-chief of Modern Law, academic technology leader in Chongqing, vice president of China Law Conference and Business Law Research Institute, and deputy director of Academic Committee of China Law Society Civil Law Research Institute. Summary of Professional Experience

In August 2004, I was elected Vice president of the Civil Law Research Institute of China Law Society. In August 2008, I was named the academic technology leader of Chongqing by the Organization Department of Chongqing Municipal Committee and the Municipal Personnel Bureau. In May 2011, I was elected as the vice president of the Law Research Institute of China Law Association, and on May 4, 2012, I was appointed as the deputy director of the Academic Committee of the Civil Law Research Institute of China Law Society. On May 25, 2017, I was appointed as the vice chairman of the Academic Committee of the Civil and Commercial Trial Professional Committee of China Trial Theory Research Society, and in August 2019, I was elected as the vice president of the Law Journal Research Society of China Law Society. In September 2019, I was elected as the standing director and member of the Academic Committee of Chongqing Law Society.

In September 2001, I was appointed as the legal adviser of Fujian Provincial People's Government, in August 2006, I was appointed as the dean of the Law School of Shanghai University, and in December 2007, I was elected as the vice president of the Legal Education Committee of Shanghai Law Society. In June 2009, I was appointed as the leader of the Law discipline Evaluation Group and the vice chairman of the 8th Academic Degree Evaluation Committee of Southwest University of Political Science and Law respectively. In November 2011, I was employed by Chongqing Municipal People's Government as an expert of Chongqing Public Safety Technical Expert Committee (Financial industry. Banking). On October 15, 2012, I was awarded the second-class professor by Chongqing Education Commission and Chongqing Human Resources and Social Security Bureau. At the same time, I am a member of the arbitration experts in Beijing, Shanghai, Guangzhou, Chongqing and Zhuhai, China as the chairman or chief arbitrator or sole arbitrator 13 cases, about 50 co-arbitrators.

Key Publications and Presentations

The viewpoint put forward in 2003 that civil law should be composed of basic elements such as human nature, people nature, nationality and ethics, not only interprets the basic value orientation of civil law from the basic theory, but also has the original nature. Moreover, it provides a strong theoretical support for the system design of integrating excellent national traditions and socialist core values into China's Civil Code.

In order to promote the formulation of China's Civil Code, I have published more than 20 relevant papers. For this purpose, I specially edited and published "China's Civil Code Contention · Zhao Wan Volume" in the series of "China's Civil Code Contention" organized by Xiamen University Press. In addition, my article "The Independence of Commercial Law and the Independence of Commercial Trial" published in the first issue of Legal Science (Journal of Northwest University of Political Science and Law) in 2012 was reprinted in full by Xinhua Digest in the seventh issue of 2012 as a key article, which has great reference value for promoting the independence of commercial trial and the reform of judicial system in our country; "The Theoretical Proof of China's Autonomous Company Law and its Institutional Realization", published in Chinese Social Sciences in 2015, provides a systematic and complete theoretical supply for the direction and path of revision of Chinese company law, which has aroused great repercussions in the academic circle.

My academic views are not only well-known in China, but also have a certain influence overseas. Second, in 2004, he published Several Issues on the Current Study of Chinese Commercial Law in the Japanese journal of Law of Cultivation. Third, in 2014, the Legal Culture Society published "Chinese Club Law に related する New たな発 exhibition" ("New Development of Chinese Company Law "). Fourthly, he has published more than 10 academic papers in journals such as Legal Studies sponsored by the Korea Law Society. Fifth, in 2005 and 2015, he published his monograph "Ethical Analysis of Civil Law" and "Outline of Civil Law" respectively in Taiwan, China, and published his paper "Theoretical Thoughts on the Improvement of Chinese Mainland Company Law" (National Lawyer, November 2004). Finally, in 2007, he was invited to become The Asian editorial board of The International journal of Law and Management.
