### Summary of Professional Experience

After obtaining the Lawyer's professional qualification in 1984, I worked at the law firm affiliated with the former Southwest Institute of Political Science and Law, handling cases such as the management of military real estate in Jiangjin, disputes over large-scale leasing equipment contracts involving foreign enterprises, and significant civil and commercial litigation cases including substantial property inheritance and division of assets in divorce proceedings involving international elements.

Since 1997, I have practiced at several renowned law firms including Sichuan Chuanda, Sichuan Deyang, and Beijing Deheng, handling nearly a hundred civil and commercial litigation cases and serving as a standing legal advisor to multiple large state-owned enterprises and government bodies.

In 1977, I was recruited as an official by the Public Security Department of the Tibet Autonomous Region. Starting from 1982, I taught undergraduate courses on civil and commercial law, real estate law,

labor law, and comparative civil and commercial law at Southwest University of Political Science and Law and Sichuan University for a long period. I have conducted legal studies in more than 20 countries and engaged in collaborative legal research in France for 8 years.

In 1999, I was invited to participate in the drafting of the Civil Code and the revision of related laws organized by the Legislative Affairs Commission of the Standing Committee of the National People's Congress at the Great Hall of the People. I have also been involved in the work of administrative regulations and regulatory documents for the governments of Sichuan Province and Chengdu City.

In 2006, I was appointed as a doctoral supervisor in law and economics and civil and commercial law at the School of Economics, Sichuan University. From 2008 to 2009, I served as a visiting professor at the Paris Institute of Political Studies (Sciences Po).

**Experience in arbitration and mediation/ ADR**

Since 1998, I have served as a standing legal advisor and business lawyer for several foreign-funded enterprises, directly handling litigation involving real estate and labor disputes, mediations, and communications with court enforcement departments to resolve dozens of cases involving real estate and financial lending disputes.

After 2003, I was hired as an arbitrator by multiple arbitration institutions, participating in the arbitration of several dozen prominent economic disputes and collective labor disputes, including the 'Golden Pond' real estate arbitration case in Chengdu, a real estate arbitration case involving a financial city in Chengdu, a labor arbitration case in Chengdu, a share transfer worth hundreds of millions of yuan for a hydropower station in Leshan, and an investment case concerning a famous commercial building in Chengdu.

Starting from 1986, I have successively published the results of major national projects such as 'Research on Integrating the Core Values of Equality and Justice into Property Rights Protection Legislation,' 'Research on the Urban-Rural Flow of Rural Real Estate Rights and Inheritance,' 'Correctly Handling Small Property Rights Housing and Innovations in Rural Land Systems' (awarded as a national excellence in 2012), and 'Research on China's Ethnic Minority Population Policies' (awarded the first prize in social sciences in Chongqing in 1997). Among these works are over 200 academic papers, including 7 academic papers published in French, 3 in Chinese, and 3 in English abroad.
