Summary of Professional Experience



Ms. Cui's practice areas include cross-border transactions, compliance, international arbitration, and foreign-related dispute resolution. She serves as an arbitrator for the China International Economic and Trade Arbitration Commission (CIETAC), Beijing Arbitration Commission, Shanghai International Economic and Trade Arbitration Commission, and the Spanish Court of Arbitration. She has presided as the chief or co-arbitrator over numerous foreign-related commercial arbitration cases, including those at CIETAC Hong Kong. As a lawyer, she has participated in cases heard by CIETAC, the China Maritime Arbitration Commission (CMAC), and the Singapore International Arbitration Centre (SIAC).

Ms. Cui has successfully assisted numerous Zhejiang enterprises in resolving foreign-related disputes through settlements, including cases handled in the US and Irish courts. Notably, she led her team in representing a central enterprise in Zhejiang in a series of bank recourse lawsuits related to a shipbuilding guarantee, securing a comprehensive settlement after four years of litigation and arbitration at CMAC. She also represented a Zhejiang state-owned enterprise in an international arbitration at SIAC against a French company over joint venture and distribution contracts, obtaining favorable settlement compensation. She has handled major contract termination disputes for a Ningbo private company with a European listed company, securing nearly 100 million yuan in settlement compensation through dual litigation and arbitration processes. Furthermore, she represented a Zhejiang private group in a 1 billion yuan capital market restructuring dispute influenced by the Russia-Ukraine conflict.

Ms. Cui's keen insight into client needs and her ability to integrate resources have enabled her to provide high-quality solutions and seek the best outcomes for her clients. Her outstanding professional performance has earned her recognition in the Chambers Asia-Pacific Lawyers List for Zhejiang Corporate/Commercial Lawyers (BAND 2) since 2018, the "National Outstanding Lawyer" title in 2021, and inclusion in the Chambers Corporate/Commercial: Zhejiang: Non-contentious Lawyers List (Eminent Practitioners) in 2024. Experience in arbitration and mediation/ ADR



Ms. Cui is dedicated to helping clients efficiently resolve foreign-related disputes through Alternative Dispute Resolution (ADR) methods. For instance, in a case involving an international sale of goods dispute she handled, she combined litigation and non-litigation strategies to assist a German client in reaching a pre-litigation settlement agreement with a listed company in China. Over the past 10 years, Ms. Cui has assisted numerous enterprises in Zhejiang in successfully resolving various foreign-related disputes through settlement, including cases litigated in courts in the United States and Ireland. Among these, Ms. Cui led a team representing a state-owned enterprise in Zhejiang in a 700 million yuan bank guarantee recovery lawsuit related to shipbuilding, spanning four years throughout the first instance, the second instance, the first instance of retrial, the second instance of retrial, and the arbitration at China Maritime Arbitration Commission, and ultimately achieving a comprehensive settlement. She also represented a Zhejiang government-owned enterprise to respond to an international arbitration over a joint venture contract and distribution contract initiated by a French company at the Singapore International Arbitration Centre, helping the Zhejiang enterprise overturn an unfavorable situation and obtain tens of millions of yuan in settlement compensation without paying a penny to the other party. Additionally, she represented a private company in Ningbo in resolving a dispute over the termination of a distribution contract involving hundreds of millions of yuan with a European listed company. Through domestic litigation and arbitration procedures, she ultimately helped the Ningbo company obtain nearly 100 million yuan in settlement compensation. Ms. Cui believes that lawyers need to work diligently to avoid the escalation of disputes from the very beginning. She advocates for a shift in mindset, recognizing that litigation is not always the best way to resolve disputes. If disputes can be settled amicably without recourse to litigation, achieving the similar effects of litigation in a shorter timeframe, it will provide a solution to the current significant increase of litigations.
