Experience in arbitration and mediation/ ADR

ADR wins with flexibility, and its greatest goal is to pursue efficiency. Its free choice of substantive law also provides convenience for parties to avoid compulsory law and general legal principles. As an intermediary or third party, the host is particularly important in the operation of ADR. The requirements for program hosts vary depending on the nature and functionality of ADR methods. The outcome of ADR processing is generally not binding, and all parties have the right to continue the litigation process or file a lawsuit with the court. At this point, how to deal with the processing results of existing ADRs and their recognized evidence, prevent the parties from abusing their "second choice right", and thus avoid the waste of dispute resolution resources, is also a major challenge left by ADRs to society.

The important inspiration that ADR brings to us is that we need to re-examine the dispute resolution concept with court trial as the absolute center, construct a reasonable dispute resolution system, appropriately position judges in dispute resolution, and let the court return to the role of the last door of social justice. To achieve this goal, the threshold for entering the litigation system should be appropriately raised, and ADR mandatory pre-emption should be moderately introduced. At present, some places have introduced people's mediation into courts and made preliminary explorations. At the same time, it is necessary to further expand the power of the parties involved in the litigation process to lead the proceedings, appropriately weaken the role of the trial period, promote the professionalization and refinement of the trial, thereby moderately increasing litigation costs and providing external impetus for parties to choose ADR.
